PROFESSIONAL SERVICES CONTRACT FOR INDUSTRIAL WASTEWATER TREATMENT FACILITY IMPROVEMENT PROJECT APPROVED

The motion was made by Alderman Wood, seconded by Alderman Petrich and unanimously carried to authorize the Mayor to execute the Professional Services Contract with Pharmer Engineering for the Industrial Wastewater Treatment Facility Improvement Project, as may be amended for the City Attorney's approval, at a proposed fee of \$236,200 for the design process only. Financing of the design is proposed to be separate from the remainder of the project, with a plan acceptable to the City and Swift, and is proposed by utility billings to Swift as expenses are incurred.

FIRST READING PROPOSED ORDINANCE VACATING PORTION OF PLATTED UTILITY EASEMENT IN SUNGOLD HEIGHTS MOBILE HOME PARK

A motion was made by Alderman Woll, seconded by Alderman Kuhle and unanimously carried to give a first reading to a proposed ordinance vacating a portion of a platted utility easement in Sungold Heights Mobile Home Park legally described as follows:

The south 40.73 feet of the west 10.00 feet of Lot 6, and the west 10.00 feet of Lot 7, all in Block 4, Sungold Heights Mobile Home Park, City of Worthington, Nobles County, Minnesota.

YMCA PRESENTATION

Andy Johnson of the YMCA presented the Council with photos of the ground breaking for the new YMCA/City of Worthington Aquatic Center, and thanked Council for their work on the project.

2009 MINNESOTA CITY PARTICIPATION PROGRAM APPLICATION AUTHORIZED
