NEW OFF-SALE BEER LICENSE APPLICATION - KWIK TRIP, INC. APPROVED

CONDITIONAL USE PERMIT - 1260 27th STREET

Matt Selof, Community Development Director, said JB Brooke Properties has submitted a request

for a conditional use permit that would allow for an approximately 45' x 60' addition to the existing warehouse/distribution center located at 1260 27th Street. Pursuant to City Code Chapter 155 Appendix E: Table 5, warehouses and motor freight terminals are permitted by conditional use only. The legal description of the property under consideration is as follows:

A tract of land in the Northeast Quarter of Section 14, Township 102 North, Range 40 West, Nobles County, Minnesota, described as follows: Commencing at the northeast corner of said Northeast Quarter; thence westerly on the north line of said Section a distance of 776 feet to the point of beginning; thence at right angles southerly a distance of 288 feet; thence at right angles easterly and parallel to the north line of said Section a distance of 170 feet; thence at right angles northerly a distance of 288 feet; thence at right angles westerly along the north line of said Section a distance of 170 feet to the point of beginning; EXCEPTING therefrom the north 35.00 feet thereof.

The City Planning Commission at its September 5, 2023 meeting voted unanimously to recommend approval of the requested conditional use permit subject to the following conditions:

1. The subject property must maintain compliance with all applicable local, State, Federal standards and requirements.

Mr. Selof said it is a straight forward project and will be low volume and low impact. There are also no concerns from neighbors.

Council Member Kielblock asked what the determination was concerning the encroachment in the setback. Mr. Selof said the applicant has three options, a ladder could be used for the door exit, the door could be moved or a variance could be sought.

Pat Janicek said he will be adding a 2700 square foot addition to the east side of the building. Frito Lay is growing and they are consolidating with Sheldon and Windom which will add two more routes. He explained after a third party inspector for Frito Lay did an inspection of the facility it was determined that an emergency exit door should be added so they added a door in on the east side of the building and added a metal removable stair case for safety reasons. In applying for the conditional use permit it was determined that the stair case is in the setback. Mr. Janicek said that he would prefer to leave it on the east side as moving the door and staircase to the south side of the building would create issues in moving snow and would be too close to the loading dock area. He said he will work with staff on applying for a variance.

A motion was made by Council Member Kielblock, seconded by Council Member Janssen and unanimously carried to approve the Conditional Use Permit at 1260 27th Street.

BUDGET DISCUSSIONS

Community Development

Matt Selof, Community Development Director, highlighted areas of his budget but reported there were no significant increases.

Public Safety

Troy Appel, Public Safety Director, said law enforcement has become increasingly challenging over the last couple of years. According to the MN POST Board, and through data established with a recent study of numerous comparable cities, the Worthington Police Departments pay grades are well below average. He encouraged Council to consider a comprehensive pay adjustments to regain viability within the difficult market. Currently, the department is down three-full time patrol officers. He noted there were no other significant changes to the department budget. Mr. Robinson said the current budget numbers do not reflect the Public Safety Aid that the City will be getting. Staff is waiting to find out the parameters of how the funds may be used.

Center for Active Living

Jill Cuperus, Center for Active Living Director, said that membership continues to increase. The grant that was received has been significant in helping with the purchase of IPADs, computers and other amenity items. She said she is currently working on another grant. Mr. Robinson said staff is suggesting to bring the Center for Active Living under the City, which would add an additional \$38,000 to the budget for wages for the Director.

Engineering

Hyunmyeong Goo, Assistant City Engineer, said the only notable change in the Engineering budget is the CIP which has been raised to \$800,000. This would aid in being able to add some projects to the schedule each year and allow for the increase in project costs.

Fire Department

Pat Shorter, Fire Chief, said there are not any notable increases in the budget. He would like to review jobs within the department. He said there is a need to get everyone trained in EMR or come up with a pay grade adjustment for those that are certified or will become certified. Council discussed the need to add more funding into the ERS budget.

Mr. Robinson noted that pre-certification will be approved at the September 11th Council meeting. He encouraged Council to consider a higher pre-certification amount since the renewal for insurance has not been received to date.

OWATONNA PUBLIC UTILITIES RATE COMPARISON STUDY

Scott Hain, General Manager, presented the results of the Owatonna Public Utilities electric and water rate comparison study for the period of July 2022 through June 2023. Based on the information included in the survey, Worthington ranked second lowest in cost in the residential and commercial electric cost comparisons and the lowest in the industrial class cost comparisons. Fourteen electric utilities were surveyed including eleven municipal utilities, two rural electric cooperatives and one investor-owned utility.

In the water cost comparisons, Worthington ranked around the middle when compared with twelve other water utilities.

GENERAL MANAGER PERFORMANCE EVALUATION

The Water and Light Commission General Manager Performance Evaluation was completed as of August 21, 2022, by each of the five Commission members. The evaluation covered the following:

CASE ITEMS

1. PROPOSED ORDINANCE PROHIBITING CANNABIS USE IN A PUBLIC PLACE

The Minnesota Legislature approved the possession and use of cannabis effective August 1, 2023. Minnesota Statute 63 authorizes local units of government to adopt an ordinance establishing a petty misdemeanor offense for a person who unlawfully uses cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products in a public place provided that the definition of a public place does not include the following:

- A private residence, including the person's curtilage or yard,
- Private property not generally accessible by the public, unless the person is explicitly prohibited from consuming cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products on the property by the owner of the property, or
- The premises of an establishment or event licensed to permit on-site consumption.

Attached as ***Exhibit 1*** is an ordinance prohibiting the use of the above defined cannabis products in any public place within the City of Worthington except those places noted above.

Fines for petty misdemeanors may not exceed \$300.00 per offense.

Should Council concur Staff's recommendation, it may approve the first reading of the proposed ordinance and establish the petty misdemeanor fine.

**ORDINANCE REGULATING THE USE OF CANNABIS
AND CANNABIS DERIVED PRODUCTS IN PUBLIC PLACES**

The City Council of the City of Worthington Does Hereby Ordain:

SECTION 1. PURPOSE AND INTENT

For the purpose of protecting public health and safety by regulating the use of Cannabis and cannabis-derived products in public places within the City of Worthington.

By enacting 2023 Session Law, Chapter 63, H. F. No. 100 [hereinafter referred to “State Legislation”], the Minnesota Legislature passed the adult-use cannabis bill. Under that bill, the adult use, possession and personal growing of cannabis will become legal August 1, 2023.

State legislation authorizes adoption of a local ordinance establishing a petty misdemeanor offense for public use of cannabis. *See* State Legislation, Art. 4, Sec. 19 (Minn. Stat. § 152.0263, subd. 5, or successor statute).

The City of Worthington wishes to be proactive in protecting public health and safety by enacting regulations that will mitigate threats presented to the public by the public use of cannabis.

SECTION 2. DEFINITIONS

Except as may otherwise be provided or clearly implied by context, all terms shall be given their commonly accepted definitions. The following words, terms, and phrases, when used in this ordinance, shall have the meanings ascribed to them except where the context clearly indicates a different meaning.

(a) **Adult-use cannabis flower.** “Adult-use cannabis flower” has the definition given to it by Minn. Stat. 342.01 subd. 3, or its successor statute.

(b) **Adult-use cannabis products.** “Adult-use cannabis products” has the definition given to it by Minn. Stat. 342.01 subd. 4, or its successor statute.

(c) **Cannabis flower.** “Cannabis flower” has the definition given to it by Minn. Stat. 342.01 subd. 16, or its successor statute.

(d) **Cannabis product.** “Cannabis product” has the definition given to it by Minn. Stat. 342.01 subd. 20, or its successor statute.

(e) **Hemp derived consumer products.** “Hemp derived consumer products” has the definition given to it by Minn. Stat. 342.01 subd. 37, or its successor statute.

(f) **Lower-potency hemp edible.** “Lower-potency hemp edible” has the definition given to it by Minn. Stat. 342.01 subd. 37, or its successor statute.

(g) **Public place.** A “public place”, means property owned, leased, or controlled by a governmental unit, including, but not limited to: a public park or trail, public street or sidewalk; as well as any enclosed, indoor area used by the general public, including, but not limited to: educational facilities, theaters, restaurants, bars, places licensed to sell intoxicating liquor, wine, or malt beverages, retail businesses, gyms, common areas in buildings, public shopping areas, auditoriums, arenas, or other places regularly and frequently open to or made available for use by the public.

(h) **Exceptions to public place or place of public accommodation.** “A public place” does not include the following:

(1) a private residence, including the individual’s curtilage or yard.

(2) a private property not generally accessible by the public, unless the individual is explicitly prohibited from consuming cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products on the property by the owner of the property; or

(3) on the premises of an establishment or event licensed to permit on-site consumption.

(j) **Smoking.** “Smoking” has the definition given to it by Minn. Stat. 144.413 subd. 4, or its successor statute.

SECTION 3. PROHIBITED ACTS

Subd. 1. No person shall use cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products in a public place unless the premises is an establishment or event licensed to permit on-site consumption of adult-use cannabis flower and adult use cannabis products. *See* State Legislation, Art. 1, Sec. 9 (Minn. Stat. § 342.09, subd. 1(2) or successor statute); *see also* State Legislation, Art. 1, Sec. 9 (Minn. Stat. § 342.09, subd.1 (7)(iii) or successor statute); and State Legislation, Art. 4, Sec. 19 (Minn. Stat. § 152.0263, subd. 5, or successor statute).

Subd. 2. No person shall vaporize or smoke cannabis flower, cannabis products, artificially derived cannabinoids, or hemp-derived consumer products in any location where the smoke, aerosol, or vapor would be inhaled by a minor. *See* State Legislation, Art. 1, Sec. 9 Minn. Stat. § 342.09, subd. 1 (7)(b)(9) or successor statute.

SECTION 4. PENALTY

Subd. 1. Criminal Penalty. A violation of this ordinance shall be a petty misdemeanor punishable by a fine of up to \$300. Violations of this ordinance shall be prosecuted by the City Attorney. Nothing in this ordinance prohibits the City Attorney from seeking prosecution for any other alleged violation of law.

SECTION 5. SEVERABILITY

If any section or provision of this ordinance is held invalid, such invalidity will not affect other sections or provisions that can be given force and effect without the invalidated section or provision.

SECTION 6. EFFECTIVE DATE

This ordinance shall be in full force and effect immediately from and after its passage and publication as required by law.
