Notable Calls

Every once in a while a call stands out due to the hard work and dedication of the officers involved.

This notable call started off one Saturday night with Officer Walton working the night shift.

Officer Walton just finished arresting his second drunk driver of the night when he returned to patrol.

Shortly after leaving the jail, Officer Walton was downtown when he saw a car fail to completely stop at a stop sign.

Officer Walton stopped the car and a back-up officer arrived shortly after. Officer Walton recognized the occupants of the car as possible suspects in the burglary of Borch's Sporting Goods in Marshall, where multiple handguns were stolen.

A continued search of the vehicle located two more stolen handguns.

Law Review: Snow Removal from Sidewalks

Worthington City Ordinance 93.08 Snow, Ice, Debris, and Rubbish

Under Worthington City Ordinance 93.08, every owner or occupant of buildings or grounds adjacent to sidewalks on the master sidewalk map is required to remove all snow and ice within 24 hours after the snow or ice has ceased to fall. Any debris or rubbish is also required to be removed within 24 hours after being deposited.

Anyone failing to remove snow, ice, debris or rubbish may be billed by the city for the cost of the cleanup.

Scam Alert: IRS Scam

The latest scam to make the rounds is another scam involving the IRS.

In this scam, the victim will receive a call from a scammer posing as an IRS agent.

The caller states the victim owes for unpaid taxes and the bill must be paid immediately. Callers who refuse are threatened with arrest, deportation, or loss of a business license or driver's license. The fake IRS agent will typically use a common name and a fake badge number to try and convince you the call is a real call from the IRS. The caller will often have the victim's social security number.

In addition, the scammer will make the caller identification box to appear that it is the IRS calling.

If this was not enough, the scammer will send

follow up emails claiming to be from the IRS or will have another scammer call who claims to be from the police or Department of Motor Vehicles.

If you receive one of these calls, hang up immediately and call the IRS at 800-829-1040 and the IRS can help determine if you actually owe unpaid taxes.

If you don't owe unpaid taxes, you can report this



to the Treasury Inspector General for Tax Administration at 800-366-4484.

In addition, you can file a complaint with the Federal Trade Commission at FTC.gov.

Ask an Officer: Snowmobiles

This month we have several questions about the operation of snowmobiles.

Is there a speed limit for snowmobiles in town?

Yes, Worthington City Ordinance 71.37 states the maximum speed limit on streets and highways in the city is 20 miles per hour.

Furthermore, Worthington City Ordinance 71.40 states the snowmobile cannot travel at a rate of speed greater than reasonable or proper under all the surrounding circumstances.

Can I drive my snowmobile across my neighbor's back yard to get to the road?

You can only drive across private property with lawful authority or with consent of the owner or occupant of the property.

Random Snowmobile Law

71.42 Leaving a Snowmobile Unattended

This law requires every person leaving a snowmobile in a public place to lock the ignition, remove the key and take the same with him. Do you have a question for a police officer, but never had the chance to ask?
