

# Winter Holiday Fire Safety

According to the National Fire Protection Association, fire departments across the United States on average respond to 210 home structure fires that started with Christmas trees.

These fires cause an average of 6 deaths, 16 injuries, and \$16.2 million in direct property damage.

Of these fires, 26% of the Christmas tree fires and 80% of the deaths were caused when a heat source, such as candles or equipment were left too close to the tree.

When the Christmas trees do catch on fire, they tend to be deadly with 1 in 34 home Christmas tree fires resulting in death as opposed to an average of 1 in 143 home fires resulting in death.

Don't let a house fire ruin your holidays! With a few safety tips, you can keep yourself and your family safe.

- Always have a smoke detector in your home and replace the batteries twice a year.
- Make sure the tree is at least three feet from any heat source, such as fireplaces, candles, and heat vents.
- Use lights that are listed as being approved by a qualified laboratory, such as UL.



- Replace any string of lights with worn or broken cords or loose bulbs. Read the manufacturer's instructions on how many strings of lights can be connected.
- Never use lit candles to decorate your tree.

With these safety tips, you can help keep your holiday season a joyous occasion.

# Law Review: Good Samaritan Law (Continued)

The second part of the Good Samaritan Law covers general immunity from liability.

The law gives general immunity for a person who, without compensation or the expectation of compensation, renders emergency care, advise, or assistance at the scene of an emergency or during transit to a location where professional medical care can be rendered is not liable for any civil damages as a result of acts or omissions by that person in rendering emergency care, advice, or assistance, unless the person acts in a willful and wanton or reckless manner.

### Scam Alert: Secret Sister Gift Exchange

There is a scam that is making its rounds on Facebook again and that is the Secret Sister Gift Exchange.

The scam starts with a message asking you to buy a gift card of \$10.00 or more and then adding your name to a list.

In exchange, the scam promises that you will receive 36 gifts.

This is a typical pyramid scheme and the use of Facebook is allowing it to spread a lot faster.

The problem with the Secret Sister Gift Exchange is that it is a pyramid scheme and sending the gift cards by mail is in violation of federal postal regulations.

This also becomes a violation of Facebook's terms of service by posting your personal information online and they could block or close your account. Play it safe and just exchange gifts with people you know in person.

### **Fentanyl Laced Heroin**

A disturbing new drug trend is starting to show up throughout Minnesota. Drug dealers are starting to lace the drug Heroin with the narcotic pain killer Fentanyl.

Fentanyl is a synthetic opioid pain medication with a rapid onset and short duration of action. Fentanyl is believed to be 50 to 100 times more potent then morphine.

Fentanyl overdoses are serious and can cause symptoms such as confusion, difficulty thinking and speaking, seizures, low blood pressure, slowed heart rate, unresponsiveness, coma, slow and shallow breathing, respiratory arrest and death.

One of the biggest dangers about

Fentanyl is that it can be absorbed through the skin and can result in adverse effects up to and including death in just minutes.

Police K-9 units are also at heightened risk of exposure to this deadly drug combination. K-9 units can be exposed to Fentanyl by inhalation by performing a sniff test of suspected narcotics.

If quick action is taken, many Fentanyl overdoses can be reversed with the drug Naloxone, commonly known as Narcan.

Naloxone can cause an acute opioid withdrawal causing sudden and unpleasant side effects. Naloxone typically "destroys the buzz" the drug user feels and they may react violently to the sudden withdrawal.

In the United States in 2014, drug overdoses were the leading cause of accidental deaths with 47,055 lethal drug overdoses. Of these, 10,574 overdose deaths were from heroin.

In 2015, over 18 pounds of heroin, or enough for about 82,000 doses was seized though out Minnesota.

According to the Minnesota State Department of Health, heroin killed 216 people in 2015 and that number is expected to rise in the near future.

If someone you know is using drugs, seek help now! Their life depends on it!
