Dispatcher Profile: Larry Rogers

The Dispatcher Profile for February is on Larry Rogers.

Larry is a native of Pipestone, Minnesota and went to Southwest State University in Marshall for Speech-Mass Communications.

After leaving college, Larry worked at radio stations in Marshall and Windom before moving to Worthington in 1976. Larry worked as the News Director for KWOA and KITN radio stations for nearly 24 years. During that time, Larry took a two year break to work as the Executive Director of the Worthington Regional Health Care Foundation.

In 2001, Larry joined the Worthington Police Department as a dispatcher and has spent the last 18 months working the night shift. Larry has found that the night shift is a different world then the day shift.



One night Larry received a call from an elderly lady asking what the emergency number is if she would need the police, fire department, or ambulance. While the question in and of itself is not unusual, the fact that she called 911 to ask the question is.

In reflection of his current duties, Larry mentioned that the toughest calls he takes and the ones that pull on his heartstrings the most are the ones where children have been hurt

or are scared. On the flip side, the calls that are the most aggravating are the 911 pocket dials and the calls where the parents give their young child old cell phones to play with. Larry commented that he has seen so many of these, he has learned to speak "2 year old".

Taser X26P

With the X26 Taser units reaching the end of their useful life, the Worthington Police Department looked for a replacement to help keep our officers safe while they performed their duties.

After careful consideration, the Worthington Police Department settled on the Taser X26P.

The X26P Taser has a similar feel to the old Tasers and uses the same cartridge that aids in training the officers on its use, but that is where the similarities end.

The X26P uses Charge Metering

technology to measure and deliver the amount of electric charge in order to maximize both safety and effectiveness.

The trilogy logs include Engineering and Event Logs that record every user action: safety activation, trigger duration with times, dates, battery life, and a pulse-by-pulse record of the charge output.

There is an upgraded battery performance using a highly improved power magazine that lasts for approximately 500 duty cycles, which is over twice as long as the previous model.



The X26P has been improved and received additional weatherproofing to resist rain and humidity.

All of these factors come together to provide officers with the most technologically advanced tool available that can increase not only officer safety, but the safety of the suspect as well.

Scam Alert: Fake Coupons

Anyone looking for a bargain has probably seen coupons on line that promise to save you money; however, they can leave you with more than you bargained for.

In a best case scenario, you won't get the bargain you were looking for and in a worst case scenario, you could end up with malware on your computer.

There are a few steps to determine if a coupon is fake.

First, if it seems too good to be true, it is.
While a coupon for 50% off your order would be nice, it is not realistic and is a probably a scam.

If the coupon is for a free item, it could be a scam. Typically, the free coupons are for new products and are generally for small items and are not circulated online.

Check for the expiration date. If the expiration date is listed 20 years from now, it could be

fake.

If the coupon does not come directly from the company website, it should be suspect.

If you have a coupon that you think may be fake, you can check them out on the Coupon Information
Center website located at couponinformationcenter.com.

This website has many of the older fake coupons, but may not have some of the newer coupons.
