## **Scam Alert: FedEx Scam**

FedEx tweeted out an alert recently that warned people about a new scam going around.

In this scam, potential victims are receiving emails or text messages that appear to be coming from FedEx.

In the message, it states that the potential victim has a package and then gives them a link to follow.

These messages can either carry a virus or are a phishing scheme trying to get your personal data.

If you receive a message like this, you should delete the message without opening it. You can also report these messages with the Internet Crime Complaint Center (IC3), the Minnesota Attorney General's Office and at abuse@fedex.com and they will investigate it.

As a reminder, companies like FedEx will not send unsolicited text messages or emails.

They will also not request money, package information or personal information.

# Common Warning Signs of a FedEx scam:

Unexpected request for money in return for delivery of a package, often with a sense of urgency.

Requests for personal or financial information.

Links to misspelled or altered website addresses (fedx.com, fed-ex.com).

Claims you won a large sum of money in a lottery or settlement.



Certificate errors or lack of a Secure Sockets Layer (SSL) for sensitive activities.

# Does Worthington still have Odd/Even Parking?

While the Odd/Even Parking ordinance is still on the books, Worthington has switched to using snow emergency declarations.

When the snow emergency is declared, all vehicles need to be off the streets to allow the street department to plow the streets as quickly and efficiently as possible.

# Is it true that if I get a ticket for having expired registration, I can purchase the registration and get out of the ticket?

Minnesota State Statute 168.09 Subdivision 5(2) states that a defense to that charge of having expired registration is if the person renews the registration and pays the motor vehicle tax and fees within ten days of being cited for the violation.

In order to use this defense, the vehicle needs to have been previously registered.

I recently saw a YouTube video where someone installed a "train horn" in their car and went around scaring people with it. Would that be illegal in Minnesota?

Yes, that would be illegal. While Minnesota State Statute 169.68 requires all motor vehicles operated upon a highway to have a horn in good working order, the statute prohibits the horn from emitting an unreasonable loud or harsh sound or whistle.

In addition, Worthington City Ordinance 130.01 Disorderly Conduct makes it unlawful for anyone to make or produce unnecessary noise by shouting or by any other means including the blowing of any automobile horn.
