Law Review: Water Emergency Conditions

Worthington City Ordinance § 53.04 Lawn Sprinkling; Water Emergency Conditions and Water Shortages gives the city the authority to restrict non-essential water use in times of emergency.

This ordinance prohibits water use for lawn and garden sprinkling, irrigation, car washing, or any other uses specified in the notice. Other water uses banned during the water emergency include: washing driveways, sidewalks, decks, patios, siding, non-commercial car washing, and other uses that are determined to be wasteful non-essential use.

Violations of this ordinance are considered to be misdemeanors and can result in a \$90 fine for a first violation and \$160 fine for a second violation. Repeated violations can result in the water service being disconnected.

Scam Alert: Car Wrap Advertising

Recently, a Worthington resident was scammed out of thousands of dollars by the car wrap advertising scam.

The scammer will typically look for victims on different websites like Craigslist or different job hunting websites.

The scammer will contact the victim with an offer to pay them \$300 a week if they agree to have their car wrapped with advertisements from widely recognized companies such as Coca-Cola, Budweiser, and Monster Energy.

Once the victim agrees to this, the company will send a check to be cashed with a portion of the money to be sent via Western Union or other money wiring services, to the company that will install the car wrap.

Just like the other money wiring scams, the check turns out to be a fake check. The person cashing the check is held responsible for paying the bank back for the amount of the check.

Corporations are very careful about their image and have large marketing departments to handle their advertising needs.

The easiest way to prevent yourself from being a victim of this scam is to never agree to wire money to anybody that you do not know personally.

Ask an Officer: Different Squad Car and Retirement of Chief

How does the police department run now that the police chief has retired?

With the retirement of Chief Cumiskey, Detective Sergeant Flynn has been appointed as Interim Chief to run the Police Department until a new chief is hired.

As an Interim Chief, Detective Sergeant Flynn can run the department for a maximum of six months before a permanent chief is hired.

Other than someone new working as chief, there is almost no change in the day to day operations of the department.
