Safety Alert: Nerf Wars

A dangerous new game, known as Nerf Wars, is spreading across Minnesota and has been responsible for several car crashes across the state.

In the game, each student pays money to be part of a team and they compete against each other. If a student is shot with the nerf gun, they are out. The last student or team left wins the money, which can be in the hundreds of dollars.

What makes this game dangerous is when the students start chasing each other in motor vehicles. attributed to car crashes in Grand Rapids, New Hope, Blaine, Chaska, and Lakeville.

These crashes included a broadside crash in New Hope, a head-on crash in Grand Rapids and a rollover crash in Lakeville that killed Lakeville South High School students Jacob Flynn and John Price.

Other dangerous behaviors that have been attributed to the game are students breaking into homes without permission and sneaking around neighborhoods with replica weapons, which the police may mistake for real weapons.



The police are asking parents to get involved and speak with your children about the dangers of this game and ask questions if you see these items in their room.

Together we can prevent a potential tragedy from happening.

Law Review: Dip Nets and Fishing

Recently the police department has been receiving calls about people using dip nets for fishing along Sherwood Street. Under Minnesota Administrative Rule 6262.0600, dip nets may be used to take rough fish from May 1 through the Sunday before the third Monday in February, except where the taking of fish is otherwise prohibited by law or rule.

This rule also allows the taking of rough fish by other means, including spear, harpooning, and archery. In Minnesota, rough fish include carp, buffalo, sucker, sheepshead, bowfin, burbot, cisco, gar, goldeye and redhorse. Border water regulations may vary.

Scam Alert: Jury Scam

Minnesota Chief Justice Lorie Gildea has proclaimed May 2 to May 6 as Juror Appreciation Week in Minnesota in appreciation for all Minnesotans who have answered the call to jury service.

Along with her proclamation, Chief Justice Gildea warned of the ever present scams that target jury duty.

The scam usually starts with a telephone call or

an email stating that you missed jury duty and then issues a demand to provide personal information or the payment of a fine.

The callers often use the threat of sending law enforcement officers to arrest someone if they hesitate to provide the information or question the caller.

Chief Justice Gildea wants to remind all Minnesotans that if they are summoned for jury duty, initial contact will always be made by U.S. Mail in the form of a juror summons from a county district court. Minnesota courts will never contact a person by phone or e-mail and seek payment of fines, Social Security numbers, or any other sensitive information in response to missed jury duty.

Ask an Officer: Headphone Use & Animal Control

Is it legal to wear headphones while driving?

Under Minnesota State Statute 169.471, No person, while operating a motor vehicle, shall wear headphones or earphones that are used in both ears simultaneously for purposes of receiving or listening to broadcasts or reproductions from radios, tape decks or other sound-producing or transmitting devices.

This statute does not prohibit the use of hearing aids or communication headsets used by firefighters or by emergency medical services personal while operating their emergency vehicles.

The short answer is that you can use headphones while driving as long as only one ear is covered with the headphone.
