### **Economic Impact Payments**

Almost 4 million Americans are still waiting for their Economic Impact Payments.

Last week the IRS started sending out the latest batch of Economic Impact Payments as a prepaid debit card in plain white envelopes.

The problem is that many people are mistaking these payments as junk mail and they have been throwing them away.

The real payment cards will come in a

plain white envelope from Money Network Cardholder Service and the debit card inside will be issued by MetaBank.

If you have discarded or destroyed your stimulus card, you can get a replacement card at no cost.

To get your replacement card, call customer service at 800-240-8100 (TTY: 800-241-9100) and select the lost or stolen option.

This will deactivate your old card and



allow you to order a new replacement card.

To check on the status of your IRS Stimulus check, you can go to the IRS Get My Payment Page and follow the prompts.



### **Crime Stoppers' App**

Crime Stoppers now has an app!!!

- To locate the app simply go to your phone's app store and type in "Submit a Tip".
- ➤ Look for the app that is named "P3 Tips" with the logo that matches the logo to the left of this article (blue square with white letter P and blue number 3)
- > The P3 Tips app is free
- > Tipsters will be directed through the app to submit a tip by selecting the state and city or county.

Tips made to Crime Stoppers is anonymous and information that leads to a felony arrest may be eligible to receive a reward of up to \$1,000.

You can report crimes or fugitives you have knowledge about, regardless of if they have been in the news or listed on the Crime Stoppers website.

### **COVID-19 Update**

On June 5<sup>th</sup>, Governor Walz released his latest COVID-19 guidelines, which start June 10, 2020.

### **Vulnerable Minnesotans**

Under the latest guidelines, vulnerable Minnesotans should continue to stay at home and social distance to protect themselves from the virus.

This group includes those at-risk for more severe illnesses, such as the elderly and individuals with underlying health conditions.

### **Large Gatherings**

Large gatherings of 10 people indoors and 25 people outdoors are still prohibited.

### **Small Businesses**

Small businesses can open with restrictions. These restrictions include only allowing 50 percent capacity, and social distancing for employees and customers.

#### **Work at Home**

If you can work at home, you are encouraged to do so.

### **Bars and Restaurants**

Bars and restaurants can start serving outdoors and indoors at 50 percent capacity.

Total indoor and outdoor dining are capped at 250 individuals.

All customers must be

seated, and social distancing must be maintained.

Dancing is prohibited.

### Salons/Movies/Fitness Centers/Pools

Hair salons and barber shops can open at 25 percent capacity.

Movie theaters, indoor concert venues, bowling alleys, fitness centers can open at 25 percent capacity.

Pools can open at 50 percent capacity.

### **Religious Facilities**

Churches and other religious facilities can open at 50 percent capacity.

### **Camping**

Public and private facilities can open as of June 1<sup>st</sup>, but need to abide by social distancing guidelines and sanitation requirements.

# Can I buy a handgun in South Dakota and bring it back to Minnesota?

Under federal law, Federal Firearms License (FFL) holders are the only people who can legally handle the sale of firearms across state lines.

If you possess a FFL, then you can legally purchase a firearm in one state and import it to another state.

If you do not have a FFL, you can still purchase a firearm in another state, but you cannot take possession of that firearm. You would need to purchase the firearm, and have it shipped to a FFL in the state where you live.

Many FFL holders are willing to do this for a small fee.

## Does a gun silencer actually make guns silent?

Firearm suppressors, commonly referred to as silencers, do not make firearms silent; far from it.

For example, a .308 rifle without a suppressor is about 167 decibels without a suppressor. With the suppressor it is 133 decibels.

A Glock 17 9mm handgun without a suppressor is about 162 decibels and with the suppressor it is 126 decibels.

To put this in comparison, a

standard police siren is approximately 120 decibels. According to the Centers for Disease Control and Prevention; loud noises above 120 decibels can cause immediate hearing damage. While suppressors may look cool in the movies, they do not make the gun silent.

They do serve an important purpose in conserving hearing for people who use and train with firearms.
