There have been many changes in the judicial system recently in Southwest Minnesota.

To start with, Governor Mark Dayton appointed public defender Terry Vajgrt as Judge for Rock County. Judge Vajgrt replaced Judge Timothy Connell, who retired after 24 years of service.

Governor Dayton also appointed Nobles County Attorney Gordon Moore as Judge for Nobles County. Judge Moore has replaced Judge Jeffrey Flynn, who retired in January after 27 years of service.

Both Judges have already started their duties as of March.

With the appointment of Gordon Moore as judge, this has left a void in the Nobles County Attorney's Office. Deputy County Attorney Kathleen Kusz has been appointed by the Nobles County Board of Commissioners to finish out Judge Moore's term of County Attorney.



The call of the month article picks one call of interest to give the reader an insight into the behind the scenes work done by the men and women of the Worthington Police Department.

This month's call involves a sharp-eyed police officer and a stolen vehicle.

The police officer was on routine patrol one night around 8:30 when he

observed a car matching the description of a vehicle stolen from Windom the night before.

A quick check of the license plates confirmed the officer's suspicions. After calling for back up, the officer stopped the stolen car and took one adult and two juveniles into custody.

The adult and one juvenile were held in the Nobles

County Jail pending court appearances, while one of the juveniles was released to his parent.

A search of the vehicle turned up property stolen during a burglary of a local residence.

# **Scam Alert: The Grand Parent Scam**

This month's scam is a common scam that is making its rounds through Worthington again.

The victim in this scam typically receives a telephone call from a person posing as their grandchild and claims they are in jail and need money wired to them in order to get out of jail.

The scammer will try to play on the emotions of the victim by begging them to send the money by making comments such as "don't you love me" if the victim questions them about what happened.

The scammer will also try to create a false sense of urgency in the victim by claiming something bad will happen if the money is not received soon.

The scammer typically will ask for several thousand dollars to be wired using companies such as Western Union.

The easiest way to protect yourself from scammers like this is to hang up on them and to call the relative they were posing as.

Many of these scammers are becoming more

sophisticated the longer this scam is around. They can use the internet to quickly learn about the people they are trying to scam. Don't be surprised if they know your name and the name of your relatives.
