

BRDTF Tips available on Apple and Android devices **New Glock Handguns**

The Worthington Police Department just replaced their tenyear-old Glock model 22 handguns with new Glock model 17 handguns.

The change in handguns was made by the officers who trained with the new handguns.

The Glock 17 and 22 are identical in size and shape, which allowed officers to quickly adapt to the new handgun.

The new Glock has the advantage of replaceable handgrips to accommodate officers of all sizes.

The biggest change with the new handgun

is the switch from .40 caliber to 9mm.

This switch came after careful consultation with other agencies that were extremely knowledgeable in the field of handguns.

The switch also had several benefits. The 9mm round has less recoil then the .40 caliber, making follow up shots easier to stay on target.

The 9mm has less wear and tear on the handguns from the lower recoil. This will allow the handguns to last longer with fewer repairs. round, the magazine capacity has increased from 15 to 17, giving officers more ammunition in case of an emergency.

The ammunition for the 9mm is significantly less expensive when compared to the ammunition for the .40 caliber. This will allow the officers to practice more, while providing a cost savings to the department.

Law Review: Drive Around Barricades

With the recently closure of I-90 due to the blizzards we had, this would be a good time to review Minnesota Statute 160.2715, which covers driving around barricades.

Under Minnesota State Statute 160.2715, it is a Misdemeanor to drive over, though, or around any barricade, fence, or obstruction erected for the purpose of preventing traffic from passing over a portion of a highway closed to public travel or to remove, deface, or damage any such barricade, fence, or obstruction.

A motorist who violates this statute can be fined up to \$1,000 and/or be sentenced to 90 days in jail. In addition, if a violator needs to be rescued from a closed road, they can be billed for the expense of the rescue.

Scam Alert: Hy-Vee Giveaway Scam

If you have been on Facebook recently, you may have seen a post recently stating that Hy-Vee is giving away \$150 in groceries for your birthday.

All you have to do is click the link and provide your information.

The only problem is that Hy-Vee is not behind this "too good to be true" offer. Hy-Vee recently issued a press release about this very issue stating that, "The giveaway is not affiliated with or supported by Hy-Vee, and customers are urged not to engage with the scam website or provide their personal information".

This scam is just another attempt to gain personal information from victims or to potentially infect the victim's computer with a virus. Anyone who has clicked on this scam link and provided personal information is encouraged to monitor their credit reports for any changes, scan their computer for viruses and malware, and to change the passwords for all accounts accessed from the computer.

Just remember, if it seems too good to be true, it probable is. Do you have a question about a scam or have
