### **National Police Week**

In 1962, President John F. Kennedy signed a proclamation which designated May 15 as Peace Officers
Memorial Day and the week in which that day falls as Police Week.

National Police Week pays special recognition to those law enforcement officers who have given their lives in the line of duty.

This year the names of 394 law enforcement officers will be added to the walls of the National Law Enforcement Officers Memorial.





295 officers died in 2020 with COVID-19 being responsible for 182 fatalities.

The names of 99 officers whose stories of sacrifice have been lost to history will also be added to the memorial.

This year, one Minnesota law enforcement officer will be added to the walls of the memorial, Sheriff Lemick Arthur Larson of the Waseca County Sheriff's Department.

Sheriff Larson died on September 29, 1940 when he was killed in an automobile crash when his vehicle was struck by another vehicle while he was transporting a prisoner.

Of the 22,000+ names on the memorial, there are 258 Minnesota officers listed there.

There are two local law enforcement officers also listed on the memorial, Worthington Police Officer Roy Robert Fitch who died on June 19, 1938 from a duty related injury and Nobles County Sheriff Terrance Joseph McCall who died by gunfire on August 8, 1920.

Have you ever wondered about the stories behind the men and women of law enforcement who have given their lives in the line of duty?

Look no further than the Officer Down Memorial Podcast (OPMP).

The ODPM is a new podcast produced by Dodge County (MN) Sheriff Scott Rose, who shares the stories

of how these men and women heroically lost their lives in the line of duty.

So far, these stories have covered Minnesota officers, but Sheriff Rose is currently working with the Omaha Police Department to tell the stories of their fallen officers as well.

The goal behind Sheriff's Rose' podcast is to honor the fallen heroes, help us remember their service, remind us that we must always support the families they left behind, and never forget their sacrifice.



### **Scam Alert: Venmo Scam**

Did someone "accidently" send you money on Venmo and now they want it back?

If this has happened to you, you might be the latest victim of the Venmo scam.

In this scam, the victim will receive a payment to their Venmo account from someone they do not know.

The scammer will follow up with a message saying that they sent the money by accident and they want you to send the money back.

If this happens to you, do not sent the money back and instead tell the person to contact Venmo to reverse the charge.

Most of these transactions are made using stolen credit card numbers and if you send the money back, you will be out the money when the credit card company reverses the charge. When you tell the scammer to contact Venmo to reverse the charge, expect they will threaten to report you to the police for theft or otherwise try to intimidate you into sending the money back.





Hold fast and do not send the money back.

This scam only works when the victim sends the money to the scammer.

## **Ask an Officer: Pocket Bikes and Scooters**

# What are the laws regarding pocket bikes and mopeds?

When operating your moped or pocket bike, here are some things to remember:

Minnesota law does not differentiate motor scooters from motorcycles in terms of licensing, titles, and registration requirements.

In order to operate a moped, you will need a driver's license. People 15 years old or older can obtain a moped permit.

Mopeds may not ride on bicycle lanes, trails, or interstate freeways.

Mopeds must operate as close to the right side of the road as possible.

Moped operators need to wear a helmet if they are under 18 years of age.

Your moped must have a working headlight on during use. Mopeds manufactured before 1987 normally do not have a headlight and may be operated during daytime hours only.

The moped also is required to have a taillight and stop lamp also.

Pocket bikes go by many names including mini-bikes, mini-motorcycles and mini-choppers, but typically resemble a miniature motorcycle.

Pocket bikes are not street legal and do not need to be titled or registered.



## When do I need to report a traffic accident to the police?

A traffic crash needs to be reported to the police if there is property damage over \$1,000 or if someone is injured or killed.

If no one is injured or killed and the damage is under \$1,000, the drivers involved can exchange information between themselves.

The information that needs to be exchanged is driver information, vehicle registration, and insurance information.
