Law Review: Odd – Even Parking

It's that time of year again! With snow in the near future, the Odd-Even parking ordinance goes into effect again on November 15, 2014.

Just a reminder:

The odd-even ordinance is in effect from November 15 until March 31.

On even number days, vehicles have to park on the even side of the street and on odd days, vehicles have to park on the odd side of the street. Look at the house numbers to determine the odd or even side of the street.



The ordinance starts every day at 12:01 a.m. (just after midnight) and is in effect until 3:00 p.m. every day.

Violations of this ordinance may result in a \$25.00 ticket and violators may have their car towed.

Scam Alert: Credit Card Lockout

Recently a Nobles County resident called to report a scam that they fell victim to.

In this scam, the victim received a call late one night from someone posing as an employee from a credit card company.

The caller stated the victim's Mastercard had been blocked and they need the victim's Social Security number to have the card unblocked.

Unfortunately, our victim was still half-asleep when the call came in and they gave the caller their Social Security number.

The victim of this scam also reported a friend of his had also received a similar call, except they were asked to enter their Social Security number in the telephone keypad.

If you inadvertently fall victim to one of these scams, there are a few things you can do to help

protect yourself. The first thing you should do is to notify your credit card company and notify them of the incident so they can take actions to prevent your credit card from being accessed online.

The next thing you should do is to place a credit freeze on your credit reports. This can be done by contacting the three major credit bureaus (Experian, TransUnion, Equafax) and requesting the credit freeze. While there is a small fee to freeze your credit and



unfreeze it, the added protection is well worth it.

Ask an Officer: The Power Hour

The "Ask an Officer" question this month comes from Mike, who asks "I'm turning 21 soon and I just heard that I cannot drink at midnight on my birthday. Is that true?"

The short answer is that you cannot drink until 8:00 a.m. on your 21st birthday.

In 2005, the Minnesota State Legislator passed Minnesota State Statute 340A.503 (5a) which is commonly referred to the power hour law.

Power hour is a term used to describe the time frame from midnight on a person's 21st

birthday until the bar closes, where someone who turned 21 would drink as much as possible before bar close.

The power hour law was a response by legislators to attempt to curb binge drinking and prevent deaths that occur from binge drinking for those just turning 21.

The law did away with the power hour by defining the age of 21 years old as occurring at 8:00 a.m. on the day of the person's 21st birthday.

In the years since the statute has gone into effect, there has been a reduction in binge drinking among 18 to 24 year olds. Thanks for the question!
