## **Halloween Safety Tips**

The Halloween season is here once again and the Center for Disease Control and Prevention has some safety tips to keep our little ghosts and ghouls safe this season.

- Swords, knives and other costume accessories should be short, flexible and soft.
- Don't allow children to trick or treat alone.
- Walk in groups and have a trusted adult along.
- Use reflective tape to help drivers see the children.
- Examine all treats for choking hazards and tampering before allowing the children to eat them.



- Use a flashlight or other light source to allow others to see you.
- Look both ways before crossing the streets and use crosswalks whenever possible.
- Walk on sidewalks whenever possible. If sidewalks are not possible, walk against traffic and stay as close to the curb as possible.
- Wear well-fitting masks, costumes, and shoes to avoid blocking vision and to prevent trips and falls.

- Avoid eating homemade treats made by strangers.
- Enter homes only if you are with a trusted adult.
- Don't stop at dark houses and never accept rides from strangers.
- Finally, never walk near lit candles or luminaries.

By following these simple tips, you can keep your children safe this Halloween.

# Law Review: Driving Through Property to Avoid Traffic Signal

Driving through Property to Avoid Traffic Signal is one of Worthington's shortest ordinances. With just 22 words, this ordinance makes it unlawful to avoid a traffic control device such as a traffic light or stop sign by driving through private property.

For example, if you were waiting at the stop light by Bob and Steve's, it is unlawful to cut through their lot to avoid waiting for the light to change.

## Scam Alert: Do Not Call List Scam

The newest scam to make the rounds is the "do not call list" scam.

In this scam, the victim will receive a call from a person posing as a representative of the National Do Not Call Registry.

The caller will claim to provide you with an opportunity to register your phone number, which will limit the number of telemarketing calls. The caller will then ask you for personal information such as your name, address, Social Security number. Some scammers will also try to charge a fee to join the registry.

In either case, the call is a scam and you should just hang up the phone.

The National Do Not Call List is a free service of the federal government so they would never ask you for a fee. In addition, private businesses cannot register phone calls on behalf of consumers.

## **Ask an Officer: Levels of Crimes**

What is the difference between the different levels of crimes, such as felonies and misdemeanors?

In Minnesota, there are four levels of offenses that include felony, gross misdemeanor, misdemeanor and petty misdemeanor.

The highest level of crime in Minnesota is a felony. A felony is any crime in which a sentence of imprisonment for more than one year can be imposed.

The next level of crime is the gross misdemeanor. A gross misdemeanor is any crime that does not constitute a felony or misdemeanor. A gross misdemeanor can include a jail sentence of up to a year and a \$3,000 fine.

A misdemeanor is a crime for which a sentence of not more than 90 days or a fine of \$1,000 or both may be imposed.

A petty misdemeanor is a petty offense, which is prohibited by statute, but does not constitute a crime for which a sentence of a fine of not more than \$300.00 may be imposed. A typical petty misdemeanor can be an offense such as a speeding ticket. Do you have a question for a police officer, but never had the chance to ask?
